New Main Street location will expand capacity and enhance patient care in early 2026

RICHMOND, INDIANA – Well Care Community Health, Inc., a leading Federally Qualified Health Center (FQHC) serving Wayne, Fayette, Union, Clark, and Scott counties in Indiana, today announced plans for a new, expanded facility at 2200 West Main Street in Richmond. The organization plans to move its main clinic operations to the new location in early 2026, significantly increasing its capacity to serve the community's growing healthcare needs.

The new facility represents a major investment in the health and well-being of East Central Indiana residents. This expansion will allow Well Care to serve more patients while maintaining its commitment to removing barriers to exceptional medical, dental, and behavioral health care for all community members, regardless of their ability to pay.

"This new facility is a testament to our unwavering commitment to putting your health first," said Eric Coulter, CEO of Well Care Community Health, Inc. "As our community continues to grow and evolve, we're growing with it. This new location will allow us to expand our services, reduce wait times, and create an even more welcoming environment for the families who depend on us for their healthcare needs."

The current Well Care facility at 203 E. Main Street has served the community faithfully, but the new location will offer expanded clinical space, enhanced technology capabilities, and improved accessibility features. The facility is being designed with patient comfort and care efficiency in mind, ensuring that Well Care can continue to provide the comprehensive, compassionate care that has made it a trusted healthcare partner for thousands of families across the region.

Well Care Community Health serves nearly 10,000 patients annually across its five Indiana locations, providing comprehensive medical, behavioral health, and dental services. The current expansion comes on the heels of the recent addition of a school clinic location for Well Care in Austin, Indiana. And as Well Care's Richmond health clinic services prepare to move to a new facility, their dental services are also consolidating and expanding at its Centerville location.

As a Federally Qualified Health Center, Well Care is committed to removing obstacles that underserved groups sometimes experience when seeking healthcare. The organization offers sliding scale payment options, accepts all forms of insurance, provides Spanish interpretation services, and offers transportation assistance to help patients access care.

"Our patients have been with us through multiple generations – many are second and third-generation Well Care families," Coulter noted. "This new facility ensures we can continue serving those families and welcome new ones for generations to come."

The new facility will continue to offer the full range of services that have made Well Care a cornerstone of community health, including:

- **Medical Services:** Adult and pediatric care, family planning, maternity care, chronic disease management, immunizations, and preventive care
- **Behavioral Health Services:** Mental health counseling, substance abuse treatment, and integrated care coordination
- **Specialized Programs:** Telehealth services, Medicare wellness visits, and community health education

The transition to the new facility is expected to be seamless, with Well Care leadership working closely with patients to ensure continuity of care throughout the move process. Patients will receive detailed information about the transition as the 2026 opening date approaches.

The new facility sits near an existing bus stop on Roseview Transit's Route 4, and Well Care will continue to offer transportation resources for patients who need them, including gas cards and bus vouchers. Construction on the new facility has begun, and regular updates can be found through Well Care's website and social media channels.
